Sentencing Statement

 It is, therefore, on 01/09/2026 **ORDERED** and **ADJUDGED** that the defendant is sentenced as follows:

AMENDED COUNT 1: Defendant is sentenced to probation for a period of 5 year(s) conditioned upon serving 180 days in county jail and credited with 6 days to run concurrent to Count 4 with the following conditions:

1. Defendant's Probation contingent on serving 180 days in BCJ but may seek early termination
2. No objection to HEDS or any programs Defendant may be eligible to obtain
3. Mandatory Megans Law and Parole Supervision for Life
4. Defendant to have no contact with Victim ██████ or their families.
5. Defendant to pay all mandatory fines and penalties on a budget of \$100.00 per month to commence 60 days after release and continuing first of every month thereafter until satisfied

AMENDED COUNT 4: Defendant is sentenced to probation for a period of 5 year(s) conditioned upon serving 180 days in county jail and credited with 6 days to run concurrent to Count 1 with the following conditions:

1. Defendant's Probation contingent on serving 180 days in BCJ but may seek early termination
2. No objection to HEDS or any programs Defendant may be eligible to obtain
3. Mandatory Megans Law and Parole Supervision for Life
4. Defendant to have no contact with Victim ██████ or their families.
5. Defendant to pay all mandatory fines and penalties on a budget of \$100.00 per month to commence 60 days after release and continuing first of every month thereafter until satisfied
